 - VPN access is available if needed
 - Windows Server Active Directory based authentication schemes for each practice
 - Separate single server and SQL instance for each practice

Pricing

Hosting is \$39 per connection per month. This cost does not include one-time license fee (\$1,200/clinician), annual cost of Support and Maintenance (\$1,195/clinician), and any other required software and services. In order to run Amazing Charts in the Cloud, you are required to purchase the annual Guardian Angel Support & Maintenance package (\$1,195/clinician).
