CMS has expanded upon its already-significant code set pertaining to chronic care beginning January 2022. The nationwide success of CCM, PCM, BHI, and RPM codes has set a precedent for this year's PFS rule. The new code set shows increased reimbursement for some of 2021's former codes, while adding brand new codes and reimbursement methods to the list.
